Note: <u>ALL Tool Fail Reason Transactions now behave in the same manner</u>. When the Tool Fail Reason parameter is enabled the Tool Fail Reason screen will be called during ALL Tool Fail Reason Transactions, regardless of whether or not they have been assigned to a reason. Where there are no reasons assigned to the transaction and the User is unable to create Tool Fail Reasons on the fly, the User will effectively be 'stuck' in the screen. This is NOT a bug, it is as a result of a configuration issue as the Administrator now has the opportunity to disable the screen from being called for the respective transaction.

To disable a Tool Fail Reason transaction, so that the screen is not called: Create a Tool Fail Reason called '_**TRANS_DISABLED**' and assign the relevant transaction to that reason.
